SHOW RULES

1. These shows are sanctioned by ARBA and NYRCBA. The show will be governed by the show rules and Standard of Perfection of the ARBA.
2. All entries (emailed or mailed) must include full entry fee. All fees must be paid prior to the show starting. If you do not come to the show, and have entered, you must still pay the entry fee.
3. Judging will be by private ear number. Permanent legible tattoo/identification in animals left ear
4. Sick rabbits will be removed from the showroom as deemed necessary by the show superintendent.
5. The show sponsors are not responsible for the loss of animals however; all reasonable care will be taken to ensure their safety.
6. The judge's decision will be final except in cases of absolute fraud. Protests must be filed with the show superintendent within 1 hour and accompanied by a \$25. fee, which is refundable if the protest is sustained.
7. The show sponsors reserve the right to substitute judges.
8. No changes to be done at the table. Changes within the same sex and class will be accepted for a \$2.00 fee at the secretary table.
9. No animals other than rabbits, cavies and certified service animals will be permitted on the grounds.
10. There will be a 2-call rule for all classes. Judging will proceed after 2 calls have been made. Please pay attention to your classes!
11. Youth showing in youth, must carry and place their own rabbits on the table.
12. This is a carrying case show. All animals must be in carriers with solid, leak proof bottoms

Scranton, PA to Herkimer County Fairgrounds

1. Head southwest on N Washington Ave toward Spruce St
2. Turn right onto Spruce St
3. Turn right at the 3rd cross street onto Wyoming Ave
4. Turn left at the 2nd cross street onto Mulberry St

Follow I-81 N and I-90 E to N Genesee St in Utica. Take exit 31 from I-90 E

5. Continue onto US-11 N/N Scranton Expy (signs for 7th Avenue/ Providence Rd)
6. Take the US-6 BUS E exit toward I-81 N/Dickson City/I-81 S/US-6 E
7. Keep left at the fork to continue toward US-6 BUS E
8. Continue onto US-6 BUS E
9. Take the exit onto I-81 N/US-6 W toward Binghamton Continue to follow I-81 N Entering New York
10. Keep right at the fork to stay on I-81 N
11. Use any lane to turn sharply left to stay on I-81 N
12. Continue onto I-81 N
13. Take exit 16A for Interstate 481 N toward Dewitt
14. Continue onto I-481 N
15. Keep right to stay on I-481 N
16. Take exit 6 to merge onto I-90 E - Toll Road
17. Take exit 31 toward I-790/NY-8/NY-12/Utica - Toll Road
18. Keep left at the fork, follow signs for Downtown/Utica and merge onto N Genesee St - Toll road

Take NY-5S E to Cemetery St in Frankfort

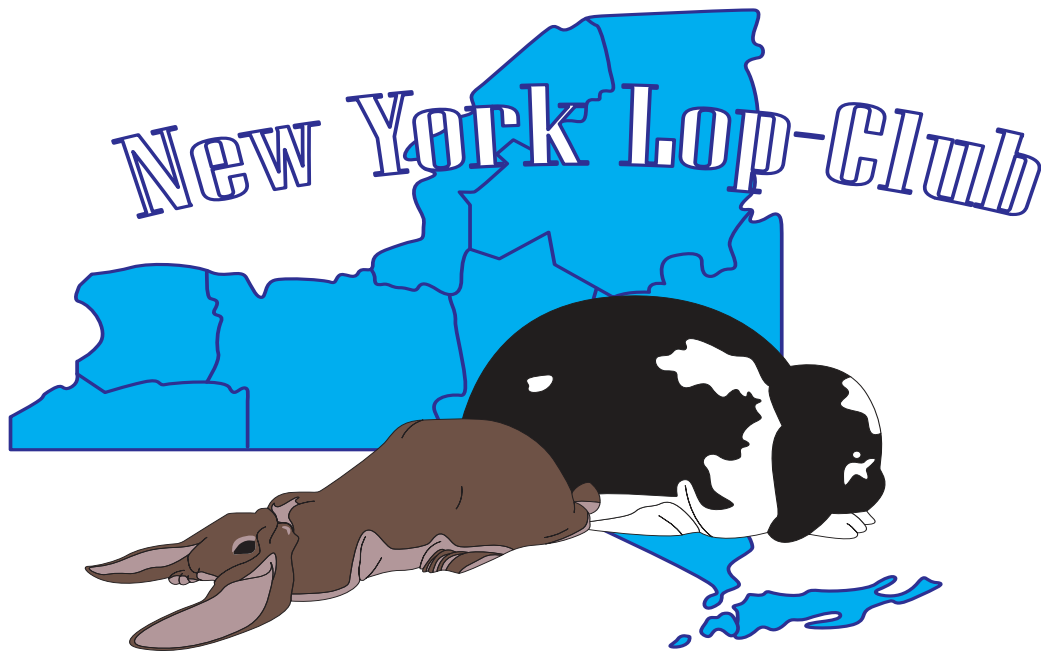
19. Merge onto N Genesee St
 20. Use the middle lane to turn slightly right at Lee St
 21. Turn left onto Broad St/Whitesboro St Continue to follow Broad St
 22. Turn left onto NY-5S E
 23. Take the exit toward Frankfort/Fair Grounds
 24. Turn left onto Higby Rd
 25. Continue onto 96/Cemetery St
- Continue to follow Cemetery St

Destination will be on the right

Boston, MA to Herkimer County Fairgrounds

1. Head south on Congress St toward Quaker Ln - 0.4 mi
 2. Turn right onto Purchase St - 39 ft
 3. Take the ramp on the left for I-90 West and head toward Quincy / Worcester - 0.5 mi
 4. Turn right onto ramp toward Albany St / Mass Pike / I-90 West - Toll road - 0.2 mi
 5. Merge onto I-90 W / Massachusetts Tpke - Toll road Entering New York - 151.3 mi, 2 hr 8 min
 6. Keep straight to get onto Berkshire Spur W - Toll road - 6.7 mi
 7. At Exit 22-61, head right on the ramp for I-87 North toward Albany / Buffalo - Toll road - 14.2 mi, 12 min
 8. Keep straight to get onto New York State Thruway W - Toll road - 1.2 mi
 9. Road name changes to I-90 W / New York State Thruway W - Toll road - 70.5 mi, 59 min
 10. At Exit 30, head right on the ramp for NY-28 toward Herkimer / Mohawk - Toll road - 0.5 mi
 11. Keep straight to get onto ramp - Toll road - 154 ft
 12. Keep straight to get onto ramp - Toll road - 210 ft
 13. Keep straight to get onto ramp - Toll road - 82 ft
 14. Keep straight to get onto ramp - Toll road - 240 ft
 15. Keep straight to get onto NY-28 / Mohawk St - 36 ft
 16. Turn left onto NY-28 / Mohawk St - 0.1 mi
 17. Bear right onto NY-5S / Revolutionary Trail - 5.2 mi
 18. Take the ramp on the right for Cemetery St and head toward Frankfort - 0.2 mi
 19. Turn right onto Cemetery St - 0.2 mi
- Continue to follow Cemetery St
